

Informazioni da fornire ex art. 13, GDPR e consenso – Final Conference “Stem4youth”

Information to be provided ex art. 13, GDPR

Personal data will be processed, mainly with electronic means, by Fondazione Umberto Veronesi – data controller – Piazza Velasca 5, 20122 (MI – Italy), to carry out activities to manage your participation in the event / workshop which you are interested in, including sending communications on the event itself. The processing of personal data for such purposes does not require the person’s consent because it is aimed at performing a task on data subject’s request (art. 5, comma 1, letter b), GDPR). They will be stored in our archives for the period of the event and according to the limits imposed by national and EU laws, regulations. Besides, participants’ data will be processed by Fondazione for the purpose of contacts promotional, information and institutional contacts on our project and for fund raising activities, surveys and researches. This activity of information (and data retention) is based on the “legitimate interest” (art. 6, comma 1, letter f, GDPR, Opinion 6/2014 WP29) of Fondazione to maintain a constant relationship with the data subject and to keep the person updated on what are the projects and the actions of awareness that Fondazione considers useful to make know to demonstrate its commitment to the realization of its mission. This legitimate interest is balanced by the person’s interest shown through the participation to the events organized by Fondazione, which means that the person shares the principles and mission of the Fondazione itself.

Data shall be stored as long as it is thought it useful to make known the development of our mission of research and as long as the person wishes to keep in touch with us: if this interest fails, data subject can exercise the right of objection and we will put in place appropriate technical, organisational measures in order not to disturb the person any longer. Then, data will be anonymised for statistical purposes and then destroyed, if not otherwise provided by supervisory authorities, law enforcement and judicial bodies. If you wish, by ticking the box, data will be processed for contacts having the purposes mentioned above but executed in a customised way according to the characteristics, interests, preferences of the person (e.g.: projects to which the person has joined, requests on our activity), that is by “profiling”. This will result in the selection of information stored in our archives about the person, so that the data subject receives only contacts which are of interest, avoiding being disturbed by unwelcome contacts.

Data shall be stored as long as the profile of the person is in line with the personalized communications created through the intersection of information at our disposal and, therefore, as long as Fondazione continues its mission with projects, Initiatives, actions and activities which require economic contributions or which encourage awareness that are of interest of the person because they reflect the characteristics and behaviours of the individual and are, therefore, of specific interest. The period of storage is reduced, if data subject objects to the processing of personal data carried out for profiling connected to direct marketing.

Data are processed by the persons authorised for the processing and acting under the authority of the data controller and in charge of: communication, events, education and institutional Department, marketing and fund raising activities, administration, information technology and data security.

Pursuant to articles 15-22, GDPR, writing to the data controller at the abovementioned postal address or by email scuola@fondazioneveronesi.it you may request the list of data processors and exercise your right of consultation, modification, cancellation, and right to be forgotten, restriction of processing, data portability, and of objection to the processing of your data on legitimate grounds or for the sending of institutional and informational communications. You have the right to lodge a complaint with the supervisory authority to enforce your rights (for Italy – Garante per la Protezione dei Dati Personali – www.garanteprivacy.it).
